

Update to End-of-Software-Maintenance dates for Extreme Summit X440-G2, X450-G2 and X460-G2 Switches

Summary:

Extreme Networks is extending the End of Software Maintenance dates for Summit X440-G2, X450-G2, and X460-G2 switch products shown below from October 31, 2026 to May 31, 2027.
